Waiver and Release

In consideration of my use of a paddle board, I, the **UNDERSIGNED**, hereby fully waive and release forever myself, my heirs, executors and administrators any and all potential rights and claims for damages, losses, demands, liability, and any other action whatsoever, which I may have against the Town of Monroe, its representatives, employees, agents and any other sponsors or volunteers, arising out of or related to any injury, disability or death that I may suffer from the use of a paddle board on Round Lake.

By signing this Waiver, I represent that I have no medical or physical conditions, which could interfere with my safety in this activity. I am willing to assume and bear the costs of all risks that may be created, directly or indirectly, by renting any equipment from the Town of Monroe.

I attest and verify that I am physically fit enough to use the paddle boards and am not under the influence of drugs or alcohol. I understand that paddleboarding has inherent risks, hazards and dangers for anyone, which cannot be eliminated, particularly in a wilderness environment. I am voluntarily using the services and equipment of the Town of Monroe with full knowledge of the inherent risks, hazards, and dangers and hereby assume and accept any and all risks or injury, paralysis, or death.

By signing this Waiver, I agree to abide by all the Town of Monroe Rules and Regulations for Paddleboarding and hereby represent that I will conduct myself in a safe and prudent manner so as not to endanger any other persons or property of any other persons.

I hereby consent to and grant full permission to the Town of Monroe to use, at the option of the Town of Monroe, any and all photographs, videotapes, motion pictures, recordings or any other reproduction of the events associated with the use of a paddle board for any legitimate purpose without limitation, reservation, or compensation to me.

I hereby agree to inspect any equipment I will be using prior to paddleboarding and will notify a Town of Monroe employee if any of the equipment is not working properly. If I fail to inspect the equipment, I will not hold the Town of Monroe, its representatives, employees, agents and any other sponsors or volunteers responsible for my failure to inspect the equipment.

I further understand that I am responsible for any damages beyond those expected from normal use. I also acknowledge and agree that the rental equipment provided by the Town of Monroe is for the sole and exclusive use of the undersigned and may not be used by any other person and solely to be use in Round Lake.

I further state that I am at least 18 years of age, or that as the parent or (adult) legal guardian, I waive and release any and all legal rights that may accrue to me, to my minor child or to the minor child for whom I am (adult) legal guardian, as the result of any injury that my minor child, the minor child for whom I am (adult) legal guardian or I may suffer while engaging in paddleboarding.

By signing this document I swear that I have read the above release and waiver of liability and fully understand its contents, and that I am of 18 years of age or older and voluntarily agree to the terms and conditions stated above.
